#### COPYRIGHT ©

It is agreed that the copyright on all images produced by the Nu Image Photography (the Studio) employees and contractors, will remain the property of the Studio unless a copyright purchase agreement has been entered into. As such it is an infringement of Copyright for any person(s) to copy the photographs, in any form.

It is further understood that the term "Copy" includes any form of copying, such as photographic photocopying, photomechanical, video, computer scanning, or any other electronic or non-electronic means of image transfer. It is also agreed that continual duplication of our photographer(s) poses and creativity by any person(s) throughout the photo session will also be considered a breach of Copyright.

ANY BREACH OF THIS COPYRIGHT AGREEMENT BROUGHT TO THE  
ATTENTION OF THE STUDIO, WILL RESULT IN LEGAL ACTION.

#### TERMS

- 1) All bookings require a coverage deposit (non-refundable) as listed, and it is agreed that payment of this deposit confirms the booking for wedding photography, as per the details and times listed. In the event of a booking being cancelled within 3 months prior to the contract wedding date a further penalty equivalent to 20% of the coverage price may also apply, at the discretion of the studio.
- 2) After the initial deposit, the remaining coverage balance, including any optional extras, is to be paid in full not later than 4 weeks prior to the wedding. Account administration charges, may be added to any overdue balances outside of these terms.
- 3) The Packages quoted herein and subject to this contract are on the basis that credit or bonus offers to be supplied AFTER your wedding are to be arranged and finalised within three (3) months of the contract wedding date appearing on the front of this Wedding Photography Booking Form. After this date the studio cannot guarantee that the credit or bonus offers can be made available at the price quoted, or at all.

#### CONDITIONS

- 1) It is agreed that the Studio representative(s) will be the only Official Still Photographer(s) in attendance, unless otherwise agreed in writing. Should the nominated photographer not be available, for any reason, the studio will provide another photographer, and do its best to notify the client of the change.
- 2) Because of the binding nature of this contract, and the importance of the occasion, the client agrees to notify the Studio of any alterations, IN WRITING, not later than 5 working days prior to the wedding. The client also accepts the responsibility to check all details, at least two weeks prior to the wedding.
- 3) Furthermore the client agrees to advise the videographer, hire cars, caterers, and any other person(s) concerned, of the schedule as listed. It is understood that the studios photographer(s) require the exclusive attention of the couple during the time specified, as per the schedule and failure to be prompt, punctual or otherwise attentive, to the studios requirements may effect the quantity and/or quality of the images produced. The studio undertakes to do all within its capacity to provide satisfactory service, however liability is limited to return of monies paid, in part or in full, at the studios discretion, should mishap or accident prevent fulfilment of our agreement.
- 4) Nu Image Photography reserves the right to use any image exposed by its employees, for the purpose of display or publication, and shall be the sole owner of the copyright and digital files unless otherwise agreed in writing.
- 5) It is agreed that the Studio will guarantee to hold prices current on the wedding day, for a period of six weeks thereafter.
- 6) Whilst the Studio makes every effort to ensure that colours are reproduced as accurately as photographic techniques will allow, exact colour matching cannot be guaranteed in every case.
- 7) "Preview" photographs (proofs), will be available within 7-10 working days, after the wedding.
